Product Description

Interleukin 17F is a cytokine belonging to the IL17 family, that is produced by inflammatory cells such as activated T cells, mast cells and basophils. IL17F is involved in allergic airway inflammation, and can induce several cytokines, chemokines, and adhesion molecules in bronchial epithelial cells, vein endothelial cells, fibroblasts, and eosinophils. IL17F may be secreted as homodimer, or a heterodimer with IL17A. It acts by binding to the type I receptor IL-17R, aiding recruitment of monocytes and neutrophils at the site of inflamation by increasing the chemokine production.

Storage Buffer

Phosphate buffered saline (PBS) with 0.09% sodium azide.

Note: Sodium azide is an extremely toxic and dangerous compound particularly when combined with acids or metals. Properly dispose of solutions containing sodium azide.




Figure 1 Indirect ELISA of IL-17F ABfinity™ Recombinant Rabbit Monoclonal Antibody (Cat. no. 701091). Indirect ELISA was performed using various dilutions of IL-17F ABfinity™ Recombinant Rabbit Monoclonal Antibody (Cat. no. 701091) to detect recombinant human IL-17F protein coated onto the plate. A non-linear regression analysis was performed (4 PL) and LOD and LOQ for the antibody was determined.
