Product Description

Intercellular adhesion molecule-1 (ICAM-1) is a member of the immunoglobulin superfamily, and is critical for the adhesion and transmigration of leukocytes from blood vessels and into tissues. ICAM-1 is constitutively present on endothelial cells, but levels increase in response to proinflammatory cytokines. It is also expressed on smooth muscle cells, resulting in leukocyte accumulation, and activation of mononuclear cells. The expression of adhesion molecules on smooth muscle cells may be cell cycle-dependent, and influence smooth muscle cell proliferation and differentiation.

When stored as instructed, expires one year from date of receipt unless otherwise indicated on product label.




Figure 1 Western blot analysis of ABfinity[™] ICAM-1 Recombinant Rabbit Monoclonal Antibody (Cat. no. 701254).

Western blot analysis was performed on whole cell extracts from Raji (lane 1), and K562 cells (lane 2). An endogenous level of ICAM-1 was detected at ~58 kDa using ABfinity ICAM-1 Recombinant Rabbit Monoclonal Antibody at a concentration of 1 μ g/mL. The blot was developed using enhanced chemiluminescence (ECL) method.

Storage Buffer

Phosphate buffered saline (PBS) with 0.09% sodium azide.




Figure 2 Indirect ELISA of ABfinity[™] ICAM-1 Recombinant Rabbit Monoclonal Antibody (Cat. no. 701254).

Indirect ELISA was performed using various dilutions of ABfinity[™] ICAM-1Recombinant Rabbit Monoclonal Antibody to detect ICAM-1 peptide coated onto the plate. A non-linear regression analysis was performed (4 PL), and LOD and LOQ for the antibody was determined.
